What are the financing issues for solar PV?

The main financing issue for solar PV in the region is that of adequate options which can serve a wide cross section of the public. Existing financing only serves those at a certain financial level who can meet certain strict requirements. Having options at each level will allow greater participation and greater uptake in the solar industry.

Can you finance a solar panel installation?

Property Assessed Clean Energy (PACE) financing is another option some consumers have to finance certain home improvements, including solar panel installation on their homes. Though module costs fell, balance-of-plant, grid-interconnection, and hedging fees climbed, keeping project finance squarely in the spotlight.
